Intervention Equipment and Services for West White Rose Platform

Scope Overview

Interventions on the West White Rose (WWR) Platform are expected to be a standard operating practice and the flexibility that they offer will be leveraged to assist with improved depletion strategies that will assist with maximizing field recovery factors. Potential interventions will include but may not be limited to:

- TRSCSSSV repair (diagnostics or installation of WLSCSSSV)
- Intervention to service down hole ESP's
- Wireline intervention to service gas lift orifice valve
- Workover to repair completion (tubing repair, gas lift valve servicing)
- ESP Deployment and Recovery
- Installing means to provide tubing-side zonal isolation
- Wellbore scale cleanout
- N2 Pumping for wellbore cleanout, lifting wellbore fluids
- Jet Perforating.
- Pressure deployment system for BHA length exceeding lubricator length.
- Data Acquisition, PLT, RST, Sampling.
- PLT fiber optic through coil.
- Milling/Drilling.
- · Chemical Stimulation treatments.
- · Well isolations, Plugging/straddles.
- Gas Lift Valve servicing.
- Production tubing/liner repair.
- Cement Squeezing/plugging.
- Plug back / isolating bottom of horizontal well
- Well Abandonment
- Coil Tubing sidetracking of an existing well may be required should the wells not meet performance requirements (compartmentalization)
- Re-perforations

Intervention/workover activities will be conducted concurrently with drilling operations.
